Canisius College Athletics Donation Request Policy

The Canisius College Athletic Department is honored to donate to numerous non-profit organizations throughout the community each year. However, due to high demand and NCAA regulations, Canisius College Athletics is not able to support every worthwhile cause.

In an effort to best process your request and support as many charities as possible, requests must comply with the guidelines listed below.

Please understand that submission of a request, even if all guidelines are met, does not guarantee that the request will be fulfilled.

Donation and Autograph Request Guidelines

- All donation requests must be received at least three (3) weeks prior to the date your item is needed.
- Canisius College Athletics will consider a donation of up to four (4) tickets to a men's or women's basketball, men's hockey, or men's lacrosse game for most donation requests. Ticket requests will be fulfilled for the sport season closest to the non-profit organization's event date, unless specifically noted in the request. If the request is approved a ticket voucher will be mailed to the non-profit organization from the Koessler Athletic Center box office. Seat locations will not be provided prior to event date.
- Due to high demand, requests for tickets to Canisius College sporting events will only be accepted for fundraisers that occur within the state of New York, or Southern Ontario.
- In certain cases, requests for head coach autographed items for charitable endeavors may be accepted. Requests for items autographed by student-athletes cannot be honored.
- If requesting an autographed piece of equipment, upon approval of request, requester must provide item (football, soccer ball, etc.). Please do not provide the item for signature until you have been notified your request has been approved.
- As a result of time constraints and NCAA rules, requests for head coach and student-athlete autographed items for personal endeavors cannot be fulfilled.
- To fulfill as many charitable requests as possible, each organization is eligible to receive only one donation per Canisius College fiscal year.
- Organizations should not advertise availability of an item until the item is received by the organization.
- Donated items may be auctioned only by the requesting organization and not sold outright.
- All proceeds from the donated items must directly benefit the charitable/nonprofit organization.
- Pursuant to NCAA regulations, Canisius College Athletics will not donate items to any entity that serves prospect-aged individuals (grade 9 12, or 7 12 in Men's Basketball and Softball), such as high schools, high school scholarship funds or booster clubs, club sports teams for high school students, specific high school students, etc.
- Donation requests should include the organization's 501(c)(3) determination letter (provided by the IRS) and documents that provide information about the event or organization.
- Due to the high volume of requests received please do not call to inquire about your request.



This form, when signed by the promotional agency involved and approved by the Athletic Department, allows athletics staff to autograph memorabilia for institutional, charitable or other educational agencies events, or to provide tickets to competition.
